The OBOR recommendations included: 1) "today's students should be exposed to an entrepreneurial curriculum, provided with real life experiences and supported in promoting their intellectual ideas"; 2) Ohio should "promote" business plan competitions with meaningful preparation awards and follow-up benefits." and, 3) Ohio should "offer competitive full and partial tuition 'Entrepreneurship Scholarships' for promising students who plan to study and engage in entrepreneurship, akin to athletic scholarships."

During 2013, the State of Ohio provided \$5,000,000 in funding that the EEO/OAS collaborative team used to successfully implement the BiO program during the 2014-15, 2015-16 and 2016-17 school years. However, during 2017, due to the state budget shortfalls, funding for the BiO program was discontinued, leaving BiO's 11,000+ student participants and their teachers without a program. EEO and OAS are seeking renewed State funding for the 2019/2020 & 2020/2021 school years.
